## Technical Report: Activity and Service Fee Use Varies Among State Universities and Community Colleges

May 2006 Report No. 06-43

#### at a glance

As a companion to Report No. 06-42, Student Activity and Service Fees Are Spent to Benefit the Entire Student Body, this technical report provides detailed information about activity and service (A&S) fee distribution at Florida's public universities and community colleges during school year 2004-05. The report is based on information provided by each institution on the student organizations that received funding from A&S fee revenue during the 2002-03 through 2004-05 academic years. One of the state's community colleges—Okaloosa Community College—does not charge an A&S fee, and four community colleges do not track A&S fund distribution to student organizations at the institutional level. <sup>1</sup> As the institutions reported somewhat different funding categories, we combined some categories to allow for comparisons among the institutions. Also, as the number of student organizations receiving A&S funds ranged substantially among the institutions (varying from 4 student organizations to 244), we focused on the top 10 student organizations receiving A&S funds in each of the past three academic years.

#### Activity and Service Fees by State University -

To allow for comparisons across the state's 11 public universities, OPPAGA grouped A&S fee allocations into seven comparable categories.

- **Student Organizations** includes honor societies and organizations such as the Student Nurses Association, the Multicultural Student Association, service organizations, the speech and debate team, and Model UN.
- **Student Government Association** includes Student Government entities, which were the top student organization receiving funds.
- **Student Affairs** includes all campus-wide programs such as career centers, volunteer centers, student legal centers, and art galleries.
- **Student Activities** includes campus activities such as homecoming or graduation.
- **Recreation** includes intramural sports teams, wellness centers, and recreation funds.
- Student Union/Life Centers includes all funds associated with the student union building.
- Reserves/Contingencies includes all funds classified as reserve, unallocated, or contingency.























#### Activity and Service Fees by Community College-

Like universities, the state's community colleges reported A&S fee expenditures in varying ways. Many community colleges reported funds by category while others reported a list of funded entities. To allow for a comparison across institutions, OPPAGA grouped funds into the categories noted below.

- **Student Organizations** includes Student Government, honor societies and organizations such as the Student Nurses Association, the Multicultural Student Association, service organizations, the speech and debate team, and Model UN.
- Student Services includes counseling and advising, career centers, salaries for staff, and child care.
- **Student Activities** includes student development, campus activities such as club festivals or graduation.
- Recreation/Organized Athletics includes organized athletic teams, intramural sports teams, wellness centers, and recreation funds.
- Financial Aid includes all funds labeled 'financial aid'.
- Institutional Allocations includes all funds distributed to campuses and/or labeled 'institutional funds'.
- **Reserves** includes all funds classified as reserve, unallocated, or contingency.

The following exhibits combine the information and illustrate the top 10 student organizations receiving A&S fees at each community college, and show a combined total for student government associations at community colleges with multiple campuses. In some cases, community colleges did not have 10 student organizations receiving funds but may have distributed funds to athletic teams and recreational divisions. Athletic and recreational organizations were not included in the top 10 listings as they were included in separate category.

Four institutions (Broward Community College, Edison College, Florida Keys Community College, and St. Petersburg College) reported that they do not track A&S fee allocations to individual student organizations. Broward Community College reported not tracking A&S funds to individual organizations, but has a formal process in place for organizations to request funds and report on how the funds were spent. Edison College reported that A&S funds are not directly distributed to organizations. Instead, organizations request funds for a sponsorship of a meeting or event and the student government association decides to allocate them funding. Florida Keys Community College did not report a separate student organization category, but instead grouped allocations by how the funds were to be spent (e.g., equipment, rentals, other services, etc.). However, this institution was able to identify organizations that received funding for the 2004-05 academic year. St. Petersburg College reported that it does not track allocations to individual student organizations centrally as its individual campuses establish budgets each year allocating these funds to student organizations. Seminole Community College provided us information on A&S fees allocated to student organizations only and did not report additional categories. Accordingly, the following tables do not provide all information for these institutions.

Exhibit 1 A&S Fee Distribution 2004-05 = \$830,000





Exhibit 1 A&S Fee Distribution 2004-05 = \$524,935




Exhibit 2 Top Student Organizations Receiving A&S Funds 2002-2005

Exhibit 1 A&S Fee Distribution 2004-05 = \$170,293.58



Exhibit 1 A&S Fee Distribution 2004-05 = \$969,432.30






Exhibit 1 A&S Fee Distribution 2004-05 = \$1,961,309





Exhibit 1 A&S Fee Distribution 2004-05 = \$447,997



Exhibit 1 A&S Fee Distribution 2004-05 = \$3,990,695



Exhibit 1 A&S Fee Distribution 2004-05 = \$865,000



Exhibit 1 A&S Fee Distribution 2004-05 = \$200,000







Exhibit 1 A&S Fee Distribution 2004-05 = \$100,525.27



Exhibit 1 A&S Fee Distribution 2004-05 = \$1,874,112.69



Exhibit 1 A&S Fee Distribution 2004-05 = \$675,356.88



Exhibit 1 A&S Fee Distribution 2004-05 = \$1,116,347.62







Exhibit 1 A&S Fee Distribution 2004-05 = \$1,265,398



Exhibit 1 A&S Fee Distribution 2004-05 = \$2,828,312


